## Minerva Delgado Dedication



In 1948, a court case challenged the Bastrop Independent School District and three other districts to desegregate. Mexican-American leaders considered education important as an avenue for social and economic betterment, yet segregation policies in the Texas school system had curtailed learning opportunities for their children. Before the Delgado v. Bastrop ISD case was filed, public education for Mexican-American students stopped at 7th grade.

The League of United Latin American Citizens (LULAC), joined by the American GI Forum of Texas, initiated the Delgado v. Bastrop ISD court case on June 15, 1948. Mexican-American attorney and civil rights advocate, Gustavo C. (Gus) Garcia represented plaintiffs Minerva Delgado and twenty other Mexican-American parents. The success of this suit, which disallowed the segregation of Mexican children in public schools, began a ten-year struggle led by the American GI Forum and LULAC which culminated in a 1957 ruling which ended pedagogical and de jure segregation in the Texas public school system. As a result, public education for Mexican-American students in Texas was raised to 12th grade.

On Saturday, September 23, the Minerva Delgado Park was dedicated, followed by the unveiling of a Texas “Undertold” Story Historical Marker at the corner of Main and Hawthorne streets, near the site of the original Mina Ward School. Judge Paul Pape and Senator Gonzalo Barrientos introduced Minerva Delgado Lopez, the lead plaintiff in the 1948 case, along with other distinguished speakers. One impressive speaker was Natalia DePaz, founder of the Young Democrats Club at the Colorado River Collegiate Academy (CRCA) in Bastrop. Natalia is an intelligent and energetic young student who is very involved in her community. She has been the National Honor Society’s president since 2016, a member of the Student Council since 2014 and a member of the Superintendent’s Student Advisory Council since 2015. By the time she graduates from CRCA in May of 2018, she will have also received an Associate’s Degree in Liberal Arts from Austin Community College.

Here are a few of her remarks: *“As I look back at the history of Delgado v. Bastrop ISD, I realize how much has changed for the better. Most people I talk to are not even aware of the case and haven’t stopped to think about its impact. 1948 was not that long ago when Mexican Americans could not have gone to high school. Certainly, a school like mine wasn’t in existence, and if it had been, its doors would have been closed to me. The educational opportunities that I have been blessed with were not open to Mexican American students in the 1940’s. If it were not for this case, or people standing together to advocate for their educational rights, we would not see the current trends in Hispanic high school graduation rates and college enrollment. According to the Pew Research Center, the percent of Hispanic students dropping out of high school is at an all-time low, and the percentage of Hispanic high school students immediately enrolling in college has never been higher. Positive change is happening and the current trends have their roots in the efforts of Minerva Delgado, the other 20 parents of Mexican American students in the case, their lawyer, Gus Garcia, and LULAC who challenged the segregation of Mexican American students in Texas public schools. Today’s ceremony and this memorial are so important to Bastrop. Most of Bastrop ISD’s students are Hispanic, and most, if not all, have goals to further their education, I being one of them. I am grateful and proud of this piece of history, and I am proud to be a student at the Colorado River Collegiate Academy, in BISD.”*

September 26 was National Voter Registration Day, and 15 of our VDRs partnered with the Bastrop Elections Office to staff voter registration tables at the Elgin ACC campus, Silver Pines

Nursing Home and all three Bastrop County public libraries. They were successful in registering 33 new voters.

## — Bastrop County Young Democrats Club Chartered at CRCA —

The Colorado River Collegiate Academy established a Young Democrats Club on Wednesday, September 13 with a growing number of 10 student members and their Sponsor Dr. Doughty. We wanted to make sure that as students and members of our community, we would have our voices and opinions heard in order to implement change. One of the events that the Young Democrats have already participated in is the DACA rally that occurred on Thursday evening, September 20. We plan to raise more awareness on this issue by hosting an information session on a Friday afternoon for the CRCA and Genesis High School. Another project we are working on is hosting a Voter Registration booth during lunch hours on Friday, September 29, in order to increase the number of voters among students who are eligible to vote. We are excited for what is next on our agenda and we hope to accomplish only good in our school and community.

## Proposed Cedar Creek Waste Transfer Station Faces Unified Opposition

About 100 Bastrop County residents gathered at Cedar Creek High School on Sept. 23 to voice opposition to a proposed waste transfer station in Cedar Creek near the intersection of State Hwy. 21 and FM 812.

Residents initially heard from two representatives of Lealco, which submitted a permit application to the Texas Commission on Environmental Quality (TCEQ) for a facility that will be a temporary dumping site for up to 2,500 tons of garbage gathered daily from Bastrop, Hays, Williamson, Travis and possibly other counties. Up to 300 garbage trucks per day would dump loads at the facility onto a concrete pad where it would be reloaded onto larger trucks and taken to a landfill. The concrete pad would be on a 10.45-acre tract that backs up to the Cedar Creek watershed and sits above the Carrizo-Wilcox Aquifer.

Residents expressed concerns about the proposed project's impact on traffic, air quality, drainage and the potential for an ecological disaster on Cedar Creek in a flood. As the TCEQ awaits input from TXDot regarding the facility's traffic plan, residents shared their grave concerns about what will happen if 300 garbage trucks and 18-wheelers are added to the often heavy traffic they already see in the area.

Rural resident and Bastrop County Democratic Party Chairwoman Cheryl Reese testified about the project's effects on local farms and ranches and the Cedar Creek and Colorado River ecosystems. Steve Chamberlain, Democratic Precinct Chair for Precinct 3016, testified about the need for a detailed traffic study to be conducted by TXDot and TCEQ before approving a permit. Bastrop County Precinct 3 Commissioner Mark Meuth also testified about the impact of increased traffic upon area infrastructure. Other elected officials in attendance included State Rep. John Cyrier and Bastrop County Judge Paul Pape.

Local water expert Phil Cook testified that the TCEQ should be reviewing the results of a survey by Bastrop County in 2011 that places most of the site in the 100-year floodplain. Several people discussed the increased frequency and severity of flooding close to the proposed project.

Sen. Kirk Watson sent a representative and has issued the following statement: "The residents of Bastrop County are right to be concerned about this project and are asking legitimate questions. It's the responsibility of our state agencies to recognize the validity of their concerns and address them thoroughly and in a timely manner. My office will continue to monitor this situation to ensure that happens."


