Please mark your calendars for two important events that Bastrop County Democrats are sponsoring in February and March: a Democratic candidate forum on Thursday, Feb. 8, and the Bastrop County Democratic Party convention on Saturday, March 24. I very much appreciate the work that the members of our candidate forum and convention committees are doing to make these events successful. I hope you will be able to attend both events as we gain momentum to turn Texas blue.

Building upon the successful candidate forum in January, we have scheduled the Feb. 8 forum for 7 p.m. at a larger venue, the Smithville Elementary School cafeteria, 800 Bishop Street. The larger location is to accommodate the 10 Democratic candidates scheduled to attend. They are vying for governor, lieutenant governor, state court of appeals, and three U.S. congressional districts. Please check our web site for the list of scheduled candidates.

Our January forum proved a little tight in accommodating the seven candidates who attended the forum at the Kerr Community Center from as far away as Corpus Christi and Cypress, thanks to our gerrymandered congressional districts.

Like the January forum, the February event will be a "speed-dating" format. Attendees will sit in one of 10 numbered groups of chairs that will be set up.

Candidates will move from group to group at 10-minute intervals, making their pitch and engaging in conversation about issues. After candidates have met with all groups, attendees can mingle and continue conversations with the candidates.

We have many excellent Democratic candidates on the March 6 primary ballot. Please plan to attend the forum to help you decide your favorites.

Meanwhile, we have begun detailed planning for our March 24 convention, which will begin at 9 a.m. at the Cedar Creek High School cafeteria, 793 Union Chapel Rd. Among other things, we will be electing delegates to the state Democratic convention and approving resolutions. We will send you more details about the convention in coming weeks. Precinct 1001 Schedules Feb. 4 Meet Your "Super" Neighbors Event

Led by the vision of former Precinct Chair Annie Marrs, who had to step down for health reasons, and implemented by Bj Jenkins and new Precinct Chair Trent Mareth, Precinct 1001 has become one of the most active Democratic precincts in Bastrop County.

Here is how it was accomplished:

- Annie Marrs searched our Voter Activation Network (VAN) and found numerous strong Democrats, based on their voting record. She called and invited them to serve on her Steering Committee.
- At the initial meeting of the Steering Committee, Annie assured attendees that there
 are lots of Democrats living in the Tahitian Village area and laid out her plan to organize the precinct by reaching out to like-minded neighbors. This meeting led to the
 establishment of the Home Visits Committee.
- Assisted by VAN data, the Home Visits Committee visited 140 homes in Precinct 1001 (yes, block-walking on those rough roads and narrow streets in Tahitian Village!).
- In addition to handing a formal invitation for their Feb. 4
 Meet Your Neighbors event to each home visited, the
 visitors conducted a survey, asking residents (1) Do you
 wish to receive the BCDP monthly newsletter? (2) Are



- you interested in attending the Meet Your Neighbors event? (3) Do you or any members of your household need to register to vote or make a change of address?
- The work of 12 committed people who visited 140 residences in Precinct 1001 will culminate Sunday, Feb. 4, with a Meet Your Neighbors social at the home of Bj and Sam Jenkins on Riverside Drive, from 2 to 4 p.m.
- All of this energy will be parlayed into ongoing "Taco Tuesdays," hosted by Precinct
 Chair Trent Mareth every third Tuesday, to keep precinct residents informed about
 upcoming important dates and events, as well as to provide a platform for candidates
 and party members to meet and discuss issues.

Precinct 1001 has now provided a model that we would love to see all the other precincts in Bastrop County emulate. This is how we Turn Bastrop County BLUE!

Legal Abortion Saves Lives

President Trump became the first sitting U.S. president to directly address the March for Life anti-abortion rally in Washington.

I would like to march for the life of a woman who doesn't want to be pregnant. If the right to a safe and legal abortion is taken away from such a woman, she will, statistics show, risk her life to end her pregnancy.

SAFE AND LEGAL ABORTION IS A WOMAN'S HUMAN RIGHT

Before the Supreme Court's 1973 Roe v. Wade decision, the procedure was not safe. It was often carried out in basements and kitchens and even in cars. The people who performed abortions frequently had no medical training.

The typical illegal abortion was done with rubber tubing, stiffened with knitting needles or bent coat hangers, inserted up the vagina, through the cervix and into the uterus. The stiffening object would be removed, but the tubing would remain in place. This source of irritation would eventually cause the woman to abort. The bloody event would happen hours or even days after the insertion.

Before abortion was legal, the lives of far too many women who had endured illegal abortion were taken by infections that need not have occurred.

What is the argument against abortion? For many, it is based on the belief that human life begins at conception. But even the Bible disagrees. In Genesis, chapter 2, verse 7, we read, "Then the Lord God formed a man from the dust of the ground and breathed into his nostrils the breath of life. Thus the man became a living creature."

Is it fair for people who don't equate life with breath to force their belief on others?

Think about it. Let's march to continue life-saving abortion rights.
